I agree to waive all claims against the Gliding Federation of Australia, the Gliding Club of Victoria Inc. and any person/s assisting in the organisation and running of the competition (including matters ancillary to the competition) for any personal or property damage or loss whatsoever.

All entrants should ensure that they have read and comply with the “Australian National Gliding Championships Competition Rules” version 1.6 dated July 2008.
